**MINUTES**

A meeting of the Cabinet was held in the Prime Minister's House, and Cabinet Division, Islamabad through Video Link Conference System on Wednesday, the 1<sup>st</sup> July, 2020. Prime Minister of the Islamic Republic of Pakistan, Mr. Imran Khan, was in the chair.

2. Referring to the poor quality of works done by PWD, the members fretted that mismanagement and corruption leave little funds for actual implementation of development projects. The status of initiating e-tendering and e-procurement was enquired. It was informed that PPRA Rules had been amended to cater for the digital mode of procurement and should come into effect anytime soon. The Cabinet constituted a Committee, comprising Minister for Economic Affairs, Special Assistant to the Prime Minister on Accountability and Interior and Secretary to the Prime Minister, to determine the reasons for the costly and substandard works done by PWD and recommend steps for rectifying the fallings.

**DECISION**

3. All Ministries/Divisions shall, where possible, adopt e-tendering, e-bidding and e-procurement at the earliest.
