O. 1057(I)/2020.—In exercise of the powers conferred by sub-section (1) of section 25 of the Civil Servants Act, 1973 (LXXI of 1973) read with Notification No. S.R.O. 120(I)/98, dated the 27th February, 1998, the Prime Minister has been pleased to direct that in the Civil Servants Promotion (BPS-18 to BPS-21), Rules 2019, the following amendments shall be made, namely:—

2. In the aforesaid Rules,—

(1) in rule 7, in clause (f), for the semi-colon at the end a colon shall be substituted and thereafter the following proviso shall be inserted, namely:—

(2229)

"Provided that this clause shall not be applicable to those civil servants who have been appointed or nominated for deputation to international organizations against reserved and specified posts, as defined in the relevant rules and are representing Government of Pakistan therein"; and

- (2) in rule 11, after sub-rule (3), the following new sub-rule (4) shall be added, namely:—

"(4) Civil servants who have been appointed or nominated for deputation to international organizations against reserved and specified posts, as defined in relevant rules, and are representing Government of Pakistan therein shall be considered for promotion subject to fulfillment of eligibility criteria."
